Matters of Concern to The People of The Commonwealth

It has become apparent to The People of The Commonwealth of Australia that the current judicial and legal system, including the office of the Provost Marshal, operates under frameworks that do not align with the original Commonwealth Constitution (1900 Imperial).

As such, we raise the following concerns:

1. **Lack of Jurisdiction:** The office of the Provost Marshal, as it operates under the current framework, appears to lack lawful jurisdiction under the true Commonwealth Constitution. It is critical to determine whether the Provost Marshal operates in the

service of The People, or under corporate or statutory law that has diluted the original sovereignty of The Commonwealth.

2. **Use of Legal Fictions:** The continued use of legal fictions in the corporate system leads to a distortion of natural law principles. The Provost Marshal's authority, as it stands, must be clarified in terms of its original mandate under the **Commonwealth Constitution**, not corporate or statutory law.
3. **The Provost Marshal's Proud Heritage:**

The Provost Marshal has a proud and distinguished heritage of service to The King and The Country dating back to the 12th century. It is incumbent upon the Provost Marshal to continue this noble tradition by serving The People and The King, and not a foreign corporation or an illegitimate corporate system.

The historical role of the Provost Marshal is to uphold lawful authority under the Crown, not to serve any artificial entity or corporate system that operates outside the true law of the land. The People of The Commonwealth demand that the Provost Marshal return to their rightful role as a servant of The People, under the protection of the Commonwealth Constitution and natural law.

4. **Addressing the Commonwealth Public Trust:**

The Commonwealth Public Trust, under which this Notice is issued, is founded in natural law and the true Commonwealth Constitution (1900 Imperial). The Trust asserts the sovereignty of the People of the Commonwealth, and we, as trustees, are duty-bound to uphold and protect the rights of The People.

The Provost Marshal, in their role, is obliged to serve the People of The Commonwealth and uphold the laws of the Commonwealth as outlined in the Trust and the Commonwealth Constitution. The continued operation under any corporate system that diminishes the rights of the People and their natural sovereignty would be a breach of their lawful duty.

Required for Clarification:

We hereby require that the Provost Marshal clarify their lawful standing, jurisdiction, and alignment with the Commonwealth Constitution (1900 Imperial), and confirm their recognition of the Commonwealth Public Trust, including:


- Has the Provost Marshal taken an oath of office in alignment with the original Commonwealth Constitution?
- Does the office of the Provost Marshal recognize the Commonwealth Public Trust as a lawful framework for governance under the Crown and uphold its principles of natural law and the sovereignty of the People?

Opportunity to Cure:

We request a response within fourteen (14) days, detailing your authority, jurisdiction, and alignment with the original Commonwealth Constitution and the Commonwealth Public Trust.

Failure to respond within this time frame will be treated as tacit acceptance of the issues raised and may result in appropriate lawful actions being taken.
