Greeting in the saving Name of Yeshua, to all whom it may concern,

Let it be known that this Notice is duly issued in honour, duty, and lawful service, for and on behalf of the living People of the Original States of The Commonwealth of Australia, as beneficiaries under the Imperial Constitution of 1900 and successors in title to our forefathers who lawfully established this Nation under Almighty God.

#### Peaceful and Honourable Reclamation of Lawful Government

This Notice is formally delivered to inform every man and woman that may occupy any office of the

United Nations and its member states, that the People of the Original States of the lawful Commonwealth of Australia have lawfully and peacefully re-established our constitutional governance under trust, in accordance with our inherited rights, natural law, equity, and the divine authority of The Creator.

We have acted without hostility, force, or rebellion. We have followed due process in equity, issued public notices, and restored the proper use of the Imperial Constitution.

### **Public Notice and Recording**

Whereas a Declaration of Trust and Founding Trust Deed (Trust Deed) has now been lawfully executed, publicly read and signed, and entered into the Commonwealth Public Record on the Thirteenth Day of the Fourth Month in the year commonly referred to as Two Thousand and Twenty-five.

This action constitutes the lawful and peaceful reclamation of the Constitutional Commonwealth of Australia — as a non-corporate, living jurisdiction — for the protection of the rights, estates, and peace of the People.

Furthermore, the Trust Deed has also been on full public display as a Public Notice at the Commonwealth Public Notice Website since the Nineteenth Day of the Fourth Month, Two Thousand and Twenty-five at https://commonwealthpublicnotice.org, and published in The Australian Newspaper on the Twenty-eighth Day of the Fourth Month, Two Thousand and Twenty-five.

### As such, lawful notice is now perfected.

#### **Notice of Fraud and Misrepresentation**

It is known by the People, Trustees, Stewards, and Custodians of The Commonwealth that your organisation and its associated political structures are registered and operating under a foreign corporate system, entirely separate from the Constitution of the Commonwealth of Australia as established by the Commonwealth of Australia Constitution Act 1900 (Imperial).

This corporate system is not a creation of The People of The Commonwealth, nor is it compatible with them — and as such, your organisation has no lawful authority to govern or rule over the People of The Commonwealth by being a Government.

Any further participation in, or endorsement of, this foreign corporate jurisdiction, especially under false colour of law or presumed authority, constitutes misrepresentation and usurpation of trust. Such actions may be construed as treasonous interference in the lawful body politic of the Crown and The People.

As such, you are hereby formally notified of the lawful re-establishment of The Commonwealth of Australia under its original constitutional form. Any presumption of jurisdiction, authority, or representation over the People of The Commonwealth, without express and informed consent, is hereby rebutted.

Let it also be known that the People are not members of any political party or foreign corporate society unless they have knowingly and voluntarily contracted to do so, with full disclosure.

Your organisation's presumed claim over the governance or representation of The People is without lawful basis and is hereby repudiated.

You are advised to cease any further presumption of lawful standing under the name of The Commonwealth of Australia, which belongs solely to the living People and the Crown under Almighty God.

**Take Notice:** Having now received the third and final publication of Public Notice in respect of the Declaration of Trust and Founding Trust Deed, duly recorded on 13 April 2025, 19 April 2025, and 28 April 2025 respectively, you are hereby made aware that the twenty-one (21) days to refute the Trust Deed's lawfulness falls on the Fourth Day of the Fifth Month, Two Thousand and Twenty-five.

### **Equitable Time to Refute and Cure**

Whereas The Trust has now been on Public Notice since 13.04.2025, with no objections to date being received — and none expected, for the truth cannot be refuted — every man and woman has been given fair opportunity to rebut our lawful standing.
