## **Notice of Acceptance of Tacit Agreement**

This Notice is issued in honour and good faith, acknowledging that lawful service of the Declaration of Trust and Founding Trust Deed of The Commonwealth Public Trust was made upon your Party's Head Office and duly perfected into the Public Record on the 13th Day of the Fourth Month, 2025.

You were afforded full and fair opportunity to lawfully rebut, refute, or bring forward any counterclaim within the prescribed period—namely by the Fourth Day of the Fifth Month, 2025. Additional grace was extended to allow for any delayed mail or late response. As of the date of this Notice, no rebuttal, affidavit, or lawful objection has been received.

"He who is silent, when he ought to speak, is deemed to consent."

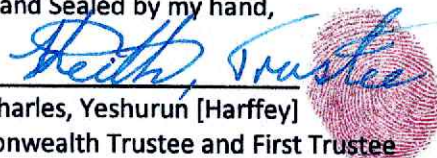
By your silence, you have lawfully entered tacit agreement with the authority, structure, and standing of the Commonwealth Public Trust. Having been lawfully served and afforded the opportunity to respond, if you now choose to continue operating within corporate governance—without full disclosure and without lawful delegation from The Commonwealth—your actions constitute wilful dishonour. You are estopped from denying the Trust, and your acquiescence is hereby recorded in law and equity.

We therefore thank you for your agreement, by way of non-rebuttal, to the peaceful and lawful re-establishment of The Commonwealth of Australia under its original and rightful Constitution, the Commonwealth of Australia Constitution Act 1900 (Imperial).

Your political party is now placed on notice that any further claim to represent the People of The Commonwealth must be made lawfully, with full disclosure, and under the authority of the Constitution and the Trust. Any continued operation under false colour of law or corporate fiction may give rise to lawful remedy sought by the Trustees, acting on behalf of the People.
