Notice of Acceptance of Tacit Agreement

Let it be known that lawful Notice and Opportunity to Respond was issued to your Office concerning the Declaration of Trust and Founding Trust Deed of the Commonwealth Public Trust, proclaimed and entered into the Public Record on the Thirteenth Day of April, Two Thousand and Twenty-five.

You were specifically instructed and expected to:

- Acknowledge the lawful re-establishment of the Commonwealth of Australia under its 1900 Imperial Constitution;
- Recognise the Trustees as lawful representatives for any international relations;
- Cease further dealings with the corporate Commonwealth without full disclosure and lawful basis.

Furthermore, let it be clearly stated that we do not rely on your system of law, jurisdiction, or authority to validate this English Common Law Trust.

However, under your own international commitments, namely the Hague Convention on the Law Applicable to Trusts and on Their Recognition (1985), adopted in Australia through the Trusts (Hague Convention) Act 1991 (Cth), you are bound by your own ratified law to recognise the validity of this Trust, its terms, its jurisdiction, and its lawful authority under the law chosen by its Founders — being the Common Law of England and the principles of Equity, as received into The Commonwealth of Australia by force of the Constitution Act 1900 (Imperial).



Therefore, your failure to lawfully rebut or respond constitutes tacit agreement and binding estoppel, both in domestic and international law, and affirms your recognition of the Commonwealth Public Trust and its lawful jurisdiction.

Having failed to lawfully rebut or respond within the allotted time, you are now held to have tacitly agreed by acquiescence. Your silence stands as your consent. You are hereby estopped in law and equity from denying or opposing the Trust, its terms, or its lawful authority.

This Notice constitutes formal and irrevocable Acceptance of your tacit agreement to the terms, conditions, and authority of the Commonwealth Public Trust.
